14 **PARAGRAPH 1:** WHEREAS, SGR No. 1 BY SEN. HEBERT IN THE SPRING
15 ORGANIZATIONAL SESSION WAS THE FIRST RESOLUTION SIGNED
16 BY PRESIDENT ALSFELD AND COMMITTED STUDENT
17 GOVERNMENT TO A POLICY OF TRANSPARENCY OF
18 COMMUNICATION BETWEEN STUDENT LEADERS AND THE
19 STUDENT BODY; AND

21 **PARAGRAPH 2:** WHEREAS, TRANSPARENCY OF COMMUNICATION IS BEST
22 ACHIEVED WITHOUT A MAILBOX BLOCKING THE DOOR BETWEEN
23 THE SENATE AND EXECUTIVE STAFF OFFICES; AND

25 **PARAGRAPH 3:** WHEREAS, THE LEGISLATIVE STAFF MUST WALK THROUGH THE
26 HALL AND AROUND THE EXECUTIVE STAFF OFFICE TO THE ONLY
27 COPY MACHINE IN WHAT ONCE WAS A TEN FEET WALK; AND,

29 **PARAGRAPH 4:** WHEREAS, THE MAILBOX PUNISHES MOST THE LEGISLATIVE
30 STAFF RESPONSIBLE FOR PRINTING LEGISLATION; AND,

32 **PARAGRAPH 5:** WHEREAS, NO MEMBER OF THE LEGISLATIVE STAFF WAS
33 RESPONSIBLE FOR THE INCIDENT THAT CAUSED THE MAILBOX TO
34 BLOCK THE DOOR; AND,

36 **PARAGRAPH 6:** WHEREAS, THE EXECUTIVE STAFF HAS NOT YET VOLUNTEERED
37 TO TAKE OVER THE LEGISLATIVE PRINTING PROCESS IMPEDED BY
38 THE MAILBOX; AND,

40 **PARAGRAPH 7:** WHEREAS, A CLOSED DOOR POLICY IS NOT IN THE BEST INTERESTS
41 OF AN EFFECTIVE STUDENT GOVERNMENT.

43 **PARAGRAPH 8:** THIS CONCURRENT RESOLUTION SHALL BECOME EFFECTIVE
44 UPON PASSAGE OF THIS LEGISLATION BY THE LSU A&M
